### Ph.D. of Entrance Test- 2023

Online Applications are invited for Ph.D. Admission Test (PAT: 2023) for admission to the Ph.D. Course. Interested and eligible applicants can fill up the online application form through the Website <a href="www.lnmupat.in">www.lnmupat.in</a> or link available on University Website: <a href="www.lnmu.ac.in">www.lnmu.ac.in</a> or on & from 29.01.2025.

#### Eligibility

- A. Candidate seeking admission to the Ph.D. Programme should have a Master's Degree with at least 55% Marks in aggregate upto or its equivalent grade 'B' in the UGC 7 point scale (or an equivalent grade in point scale wherever grading system is followed) in the subject/ in allied subject from recognized University.
- B. A relaxation of 5% of marks i.e. from 55% to 50% or an equivalent relaxation of grade may be allowed for those belonging to SC/ST/BC/EBC/Differently-abled categories of candidates.
- C. Candidates may apply for PAT-2023, who passed the Master' degree upto academic Session 2021-23.

#### **Exemption from the PAT: 2023**

- A. Candidate who have passed NET/JRF/BET/PAT-2020, 21&22 of LNMU and/ or have secured grants for research such as fellowship/ scholarships offered by DBT/ICMR/ICAR/DST/CSSIR/ICHR etc. will be exempted from Ph.D. Admission Test.
- B. Assistant Professor, Associate Professor and Professor who have been appointed on substantive post in the UGC Pay scale in the teaching Department of the University or a Constituent College of this University, who have completed their probation successfully, with an experience of at least of two years of uninterrupted service would be exempted from the Test. Teachers appointed in self-finance Course and teachers belonging to those colleges running on self-finance basis will not be exempted from the Test.
- C. Non-teaching employees of this University, who are holding substantive appointment for more than five years and have secured at least 55% marks in Master's Degree in the subject concerned, and have published at least two research papers in any reputed referred journals or journals identified by the UGC would also be exempted from the Test.
- D. Candidates passed the PAT-2020 or PAT-2021-22 will be exempted from Ph.D. Admission Test.

Note: 01.: Candidates exempted from PAT-2023 are also required to apply online with requisite fee.

Note: 02.: Candidates of exempted categories will have to appear directly before the interview board as per the schedule published, along with candidates who have qualified PAT-2023.

Duly filled-up and completed forms can be submitted online alongwith necessary supporting documents and requisite Test Fee from 29.01.2025 or as per the schedule. Application Form incomplete in any respect will be rejected.

#### **Entrance Test Fee:-**

A. General/BC/EBC - Rs. 3000/B. SC/ST/Disabled/Women/EWS - Rs. 2000/C. Late Fine - Rs. 500/-

#### **Mode of Payment of Test Fee:-**

Candidates are required to make Only Payment (Non-refundable) through the payment Gateway displayed in course of filling up the online application form.

#### Pattern of Test:-

Ph.D. Admission Test (PAT-2023) will consist of two papers of 100 marks each.

**Paper-1:** Shall consist of 50 multiple choice questions on qualitative teaching and

research aptitude.

Paper-II: Shall also consist of 50 multiple choice questions from the Core

Course/Paper-01 to Core Course/Paper-14 of the PG Subject/ Programme

concerned.

Test of both the papers will be held in a single sitting of two hours and forty-five minutes, i.e. from 11:00 AM to 01:45 PM. Question Booklet alongwith OMR Sheet of Paper-I. After that, question booklet of Paper-II will be issued to them. They will have to submit the OMR Sheet of Paper-II on completion of another one hour and fifteen minutes (i.e. at 01:45 PM).
